- b) The institution shall pay salary to the teaching staff as prescribed by UGC/University through Account Payee Cheque.
- c) The number of administrative staff shall be maintained as per NCTE norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by concerned affiliating University/UGC. The qualifications of the administrative staff shall be maintained as per norms prescribed by concerned State Govt./affiliating University.
- d) The institution shall obtain affiliation from the examining body before the commencement of the course.
- e) The institution shall maintain and update their website as per NCTE regulations.
- f) Apart from the qualifications prescribed for teachers for B.Ed. Course, the candidate shall have to qualify NET/SLET qualifications or alternative qualifications thereto as prescribed by UGC from time to time before the commencement of the academic session 2009 2010.
- g) The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- h) Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
- 5. The institution shall submit to the Eastern Regional Committee a Self Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Charted Accountant.
